Games - Through participation in 379 local competitions and eight program championships, over 31,779 Special Olympic athletes from Florida have ample opportunity to practice and hone their skills. With 23 different sports being offered year - round, there is something for everyone.

Training of 31,779 athletes in functional sports skills and rules which empower and enable them to interact with the community. Training takes place not only as part of the Olympic type sports offered, but also through our Young Athletes Program and Athlete Leadership courses to enhance our athletes opportunities within our community. While providing the athletes with opportunities to build muscles and sharpen motor skills, training also builds self-confidence and the development of social skills that will help them live a better life.

Healthy Programs - Striving to improve athletes' ability to train and compete through improving their health and fitness, and enhancing their well being and overall sports experience. Athletes are offered screening in seven disciplines, including health promotion, sports physicals, physical therapy, hearing, vision and dental care. During 2015 the program performed 8,946 health screenings with the assistance of 2,035 health care volunteers.
